**REQUEST FOR STATUS UPDATES AND MILESTONES ON MAINTENANCE
ISSUES IDENTIFIED ON THE 3RD QUARTER 2016 INDEPENDENT MONITOR AND
IMPACTS OF JANUARY & FEBRUARY 2017 STORM EVENTS

Dear Mr. Sherman,

At its January 26 and February 16, 2017, Facility & Plan Review Subcommittee (FPRS) meeting, the members of the Subcommittee were made aware of the continuing maintenance issues which were described in the Landfill's Third Quarter 2016 Independent Monitor Quarterly Site Monitoring Report (Status Report) dated December 22, 2016. The Status Report indicated that *"The frontage retaining wall and walkway along San Fernando Road had no removal of soils. The oak trees at the top of the slope...were lacking soil around their roots. In late September (2016), the frontage retaining wall and walkway soil loading condition and drainage had additional sloughing from the hillside. Soil top loading is bulging out the cyclone fence. No maintenance has occurred."*

Given the magnitude of the most recent storm events across Los Angeles County, and the impacts on operation and maintenance of the Landfill and its various environmental control facilities, the Task Force respectfully requests Republic Services to provide status updates and milestones on its effort to mitigate these identified maintenance issues.
