REQUEST FOR INFORMATION ON THE INTERMEDIATE COVER ENHANCEMENT DEMONSTRATION PROJECT AT SUNSHINE CANYON CITY/COUNTY LANDFILL

The Los Angeles County Solid Waste Management Committee/Integrated Solid Waste Management Task Force (Task Force) understands that Republic Services (Republic) has completed the Intermediate Cover Enhancement (ICE) Demonstration Project at the Sunshine Canyon City/County Landfill (Landfill). The project concluded with preparation of the Final Evaluation Report dated December 8, 2017. The intent of the project was to evaluate the use of Posi-Shell® as the Landfill's potential intermediate cover enhancement.

With the goal of ensuring the health and safety of residents in the communities neighboring the Landfill, the Task Force has been closely monitoring the progress of the ICE Demonstration Project. Therefore, the Task Force respectfully requests the following:

- Provide the performance results and findings derived from the use of Posi-Shell® as a standalone product. For the findings, include its effectiveness in controlling landfill gas surface emissions, odor, and leachate leaking from intermediate slope areas;
- Provide the benefits from the use of Posi-Shell® at the Landfill, including justification; and
- Does Republic have any specific plans for the future use of Posi-Shell® at the Landfill. If so, please explain why and provide any appropriate justification.
