### **Statutory Authority**

- AB 341 and AB 1826 authorize CalRecycle to conduct reviews of jurisdictions' mandatory commercial recycling (MCR) programs and mandatory commercial organics recycling programs at any time in addition to the regular two to four year review cycle.
- In January 2017, the Director of CalRecycle sent a memo to Jurisdiction's Elected Officials and Recycling Coordinators outlining how CalRecycle plans to exercise its statutory authority to review jurisdictions' MCR and mandatory commercial organics recycling programs more frequently as needed.

## Jurisdiction Review by Local Assistance and Market Development (LAMD)

LAMD staff conducts a 4 year Jurisdiction Review to determine if the jurisdiction:

- 1) Met reporting requirements because:
  - it has adequately implemented its diversion programs and has achieved the diversion requirement, including MCR; or
  - while it has not achieved the diversion requirement, it has made a good faith effort to implement diversion programs; or
- 2) Failed to implement its Source Reduction and Recycling Element (SRRE) and Household Hazardous Waste Element (HHWE) programs.

# Jurisdiction Review by Local Assistance and Market Development (LAMD)

The sources of information available to CalRecycle for evaluation of a jurisdiction's waste diversion performance include, but are not limited to:

- ■Annual reports
- ■Site visits
- Source Reduction Recycling Element and Household Hazardous Waste Element
- Agenda items from previous years
- Disposal reporting information and information from haulers' reports
- Petitions for time extensions or reduced diversion requirements
- □ CalRecycle correspondence

## Jurisdiction Review by Local Assistance and Market Development (LAMD)

#### LAMD:

- Determines if responses from the Jurisdiction are adequate.
- Refers inadequate responses to the Jurisdiction Compliance Unit (JCU) for consideration of a <u>Compliance Order</u>.
- Notifies the Jurisdiction's Annual Report Contact Person that an independent review of the Jurisdiction's commercial waste management program is necessary.

## Review and Compliance Orders PRC Section 41825

JCU initiates the 60-day conferring period by sending the "Notice of 60-Day Conferring Period" letter to the Jurisdiction Contact Person

CalRecycle sends the "30-Day Notice of Intent to Issue the Jurisdiction a Compliance Order"

Includes public hearing date

CalRecycle determines good faith effort

and

informs Jurisdiction

CalRecycle signs Compliance Order and informs Jurisdiction

#### Jurisdiction Compliance Unit (JCU)

#### JCU staff:

- Conducts an independent review (includes site visits).
- Prepares a staff report which includes an analysis of various <u>factors</u> per PRC section 42649.3.
- Signs a <u>Request for Action</u> which recommends either the Jurisdiction:
  - □Complied with the MCR law.
  - Made a good faith effort to comply with the MCR law.
  - □ Did not make a "good faith effort" to comply with the MCR law and recommends issuance of a <u>Compliance Order</u>.

#### Good Faith Effort

- Generally, "good faith effort" means all reasonable and feasible efforts by a jurisdiction to implement its MCR program.
- The evaluation of good faith includes, but is not limited to, the <u>factors</u> found in PRC section 42649.3

#### **Evaluation Factors**

- Extent to which businesses have complied with reporting information on amount of disposal being diverted and the number of businesses that are subscribing to service.
- The extent to which the jurisdiction is conducting education and outreach.
- The extent to which the jurisdiction is monitoring businesses, and notifying those businesses that are out of compliance.

#### Examples

#### The Jurisdiction:

- Has a low commercial recycling rate.
- Did not implement procedures to ensure the haulers are reporting required information on an annual basis.
- Did not adequately demonstrate monitoring and educational outreach activities during the review period.
- Did not receive responses from all of its haulers to provide MCR numeric information or information reported was inconsistent.
- Failed to provide documentation that they informed businesses not recycling what the law is and how they can recycle.
- Did not track or ask their haulers to report on their follow up efforts to have non-compliant businesses recycle.

### Compliance Order and Schedule

- The Compliance Order includes specific steps for the local agency or regional agency to complete, including program changes and new programs.
- The JCU and LAMD staff work with the jurisdiction to develop a Local Implementation Plan (LIP).
- The LIP identifies the specific programs and timelines for implementing the specified programs.
- A jurisdiction which fails to comply with a CalRecycle Compliance Order may be fined up to \$10,000 per day until it implements its SRRE and HHWE and complies with the Act.
