Mr. Clark Ajwani reported that the ATAS discussed the Board of Supervisor's approval of Public Works' contract with Alternative Resources Technology Incorporated to continue facilitating the development of conversion technology projects. The ATAS discussed a potential site visit after the completion of the CR&R facility.

V. REPORT FROM THE FACILITY & PLAN REVIEW SUBCOMMITTEE (FPRS)

Ms. Betsey Landis gave her report from the Facility and Plan Review Subcommittee. During the month of January a total of 259 complaints were made to the Air Quality Management District (AQMD) hotline. In comparison with December 2014, the number of complaints decreased by 6 percent (from 277 to 259). Compared to January 2014, the number of complaints increased by 710 percent (from 32 to 259). Ms. Landis shared the odor complaint charts provided by Mr. Karlo Manalo that depict number of odor complaints, surface gas emissions, and leachate generated at the Sunshine Canyon Landfill. She also mentioned that Mr. Rob Sherman of Republic Services requested the Subcommittee to include information on the intensity of odors based on AQMD inspection reports on these charts.

Mr. Ed Pupka commented on Mr. Sherman's request to the Subcommittee and stated that AQMD inspection reports are available for anyone to obtain through a Public Records Request Act.

Ms. Landis also reported that the Task Force letter to the Regional Water Quality Control Board regarding the Regional Board's Monitoring and Reporting Program for the Sunshine Canyon Landfill was sent out. In regards to the Fourth Quarter Vegetation Report for the Sunshine Canyon Landfill, Ms. Landis reported that according to a recent vegetation meeting she and Mr. Russell Bukoff attended at the Landfill, the sage mitigation areas seemed to have shown more plant growth especially with the recent rain events. Additionally, she reported noticing traces of wildlife returning to these areas of the Landfill. This is good news since it is one of the goals of mitigation.

Ms. Landis also reported that Ms. Anna Gov discussed Finding of Conformance (FOC) reports from various facilities. She mentioned that Mr. Mike Mohajer inquired about other Landfills that may have a FOC but are not reporting to the Task Force. Consequently, staff was asked to look into which facilities need to submit FOC reports to the Task Force.

Mr. Mohajer brought up an important topic discussed during the meeting regarding Republic's definition of temporary slopes, permanent slopes, and nonpermanent cut slopes, which was discussed in detail. He emphasized that the County's Conditional Use Permit and City's Zoning Ordinance have specific requirements with regards to these types of slopes that Republic would have to follow. Ms. Landis added that Sunshine Canyon Landfill staff has not been able to map the different types of slopes of the Landfill. VI. MATTRESS STEWARDSHIP PRESENTATION

Mr. Mark Patti from Mattress Recycling Council gave the <u>attached presentation</u> to the Task Force giving an overview of the Used Mattress Recovery and Recycling Act SB 254 and SB 1274.

Ms. Landis asked about the mattresses infested with fleas and bed bugs. Per Mr. Patti, fleas and bed bugs die at 113 degrees and in addition the mattresses are fumigated before they go to the trailer and recycler. Mr. Pupka asked about the air quality of the facility to put into place. Mr. Patti was going to look in to that question. Mr. Ron Saldana questioned where they get the estimate of 2.1 million recycled mattresses. As far as a total capability of recycling mattress, Mr. Patti does not have the information. Mr. Saldana asked, "Will they be profitable?" Mr. Patti said yes, as to how profitable, it will be known after they receive the RFPs. Ms. Reina Pereira asked "Are you open to work with municipalities to work on a cost?" Mr. Patti answered, "absolutely." Mr. Gerry Villalobos asked how and who will determine the level of contamination, per Mr. Patti answered that it would be the recyclers.

Mr. Patti added that the retailers have a contractor to take the old mattress. The retailer does not receive any funding. Consumers will pay a mattress recycling charge for the purchase of a new mattress and the monies would be remitted to MRC. The retailer cannot charge a haul-away fee for taking back a used mattress. It is required that the retailer tag the mattresses. A white tag means it's a new mattress, red tag means it's been sterilized, a yellow tag means it's refurbished materials.

Mr. Mohajer gave a scenario, if a Public Worker takes a mattress to the transfer station, will the Stewardship Program pay the local government? Mr. Patti answered that only if they have an MRC bin. Mr. Mohajer asked Ms. Jennifer Wallin, how the Mattress Recycling Council's request for jurisdictions to locate mattress collection containers at their yards/facilities would be considered in relation to existing regulated limits on the amount of material that can be stored on site. Ms. Wallin will get back to the Task Force on that question.

Mr. Carlos Ruiz asked several questions, "Isn't the motivation for having a Stewardship Program to reduce the cost to municipalities?" Answer: It is. If you want to participate in the program, MRC will provide municipalities with a bin. Isn't CalRecycle developing regulations for the program? Answer: Yes, MRC will be implementing the program based on the regulations. Is this MRC's proposal in terms of reducing costs to municipalities and have you received feedback from CalRecycle if your proposal will be consistent with their regulations? Answer: MRC has been in discussions with the Mattress Advisory Committee of which one of DPW employees (Frank Chin) is a member along with other stakeholders, and they are aware of the steps MRC has undertaken thus far. The mattress

recycling plan still needs to be submitted to CalRecycle for approval; it is due July 1.

In addition, there are educational materials being produced to send out to the public to let them know about the Program. Mr. Mohajer offered to help out with distributing the educational information by including an article on the Inside Solid Waste newsletter.

VII. CALRECYCLE UPDATE

WORKSHOPS AND RULEMAKING

AB 1826 Mandatory Organics Recycling (MORe) Implementation and AB 1594 Guidance

CalRecycle is still developing the implementation/guidance for the recently signed mandatory organics recycling laws. Information about AB 1826 can now be found at http://www.calrecycle.ca.gov/Recycle/Commercial/Organics/, and a comprehensive F.A.Q. resource about the law will be available shortly. In April, CalRecycle will hold spring workshops that will discuss the implementation process in great detail and provide an opportunity for additional questions:

Organic Materials Management Regulation Revisions

After receiving comments from a series of informal stakeholder workshops discussing 14 issues to be addressed in the rulemaking process, staff developed proposed regulations and completed an Economic and Fiscal Impact Analysis of the proposed regulations and Initial Statement of Reasons between October 2013 and September, 2014. The proposed regulations, Economic and Fiscal Impact Analysis, and Initial Statement of Reasons were subsequently filed with the Office of Administrative Law to initiate the formal rulemaking process.

CalRecycle began the formal rulemaking on October 10, 2014. A public hearing to receive oral and written comments was held on December 10, 2014. CalRecycle will hold an informal workshop on March 3, 2015, to discuss potential changes to the proposed regulations in response to stakeholder comments. The workshop will be held from 1 p.m. to 3 p.m. at CalEPA Headquarters. You will be

GRANT UPDATES

At the February 17, 2015, Public Meeting, the Eligibility Criteria, Evaluation Process, and Funding Allocations for the Local Conservation Corps Grant Program (California Beverage Container Recycling Fund, Electronic Waste Recovery and Recycling Account, California Tire Recycling Management Fund, and California Used Oil Recycling Fund, Fiscal Year 2015–16) were presented. The total funding amount is \$21,414,454. Eligible applicants for this grant program are Corps that is designated by a county to perform litter abatement, recycling, and related activities, and that are certified by CCC.

OPEN GRANT/LOAN CYCLES

<u>Solid Waste Cleanup Grants and Loans Program Loans to Local Governments</u> The application period for solid waste cleanup loans to local government is continuous. Used Oil Competitive (UOC) Grant Program (FY 2015-16)

The purpose of this grant program is to reduce the potential for illegal disposal by increasing used oil and filter collection, recycling opportunities, public education, source reduction, reuse of used oil, and the prevention of stormwater pollution from used oil. For local government agencies, the UOC Grant Program provides additional funding to augment or expand oil and filter collection and informational programs established by funding they receive from CalRecycle's Oil Payment Program.

Applications will be evaluated and scored by a review panel of CalRecycle staff, based on the attached Scoring Criteria.

Eligible applicants for this cycle include the following entities:

- California cities and counties
- California joint powers authorities (JPA) and special districts, responsible for solid waste management, sanitation, or stormwater management
- Nonprofit organizations (not including private schools) with the support of a local jurisdiction
- Regional programs (consisting of two or more eligible entities)

Eligible applicants may apply individually or as a participant in a regional application that involves more than one eligible entity. An applicant may not submit multiple applications. One entity must be identified as the lead applicant to act on behalf of itself and its participating applicants.

The focus of the grant cycle is based on a survey of stakeholders conducted in August 2014. Survey results indicated a greater interest in priorities consistent with the focus areas below. All applicants must include one or more of the focus areas in their application to be eligible for this cycle:

- Public education and outreach to inform the public of local used oil and filter recycling opportunities and ways to prevent stormwater pollution caused by used oil
- Implement or expand a used oil and filter collection program (includes, but is not limited to, local facilities, marinas and curbside)
- Mitigation projects preventing used oil stormwater pollution (only available to those entities with an approved stormwater management plan)

Proposed Changes

- 1. Include JPA's as Eligible Applicants Joint powers authorities (JPAs) and special districts have been included as eligible applicants for this cycle.
- 2. Decrease Maximum Grant Award Amounts

Due to a decrease in available funding, the maximum award amounts have been reduced from past cycle. Individual applicants may request up to \$100,000 and regional applicants (e.g., two or more eligible applicants) may request up to \$250,000 for their proposed projects.

- Revise Scoring Criteria
 A project description category has been added to the Scoring Criteria to assess project scope and the point distribution has been adjusted.
- 4. Revise Non-Profit Requirements

Non-Profit organizations are required to submit a letter of support from their local jurisdiction.

Local Government Waste Tire Enforcement (TEA) Grant (FY 2014/15)

CalRecycle receives an annual appropriation from the California Tire Recycling Management Fund to administer the Tire Recycling Act (Senate Bill 937, [Vuich, Statutes of 1990, Chapter 35]) and related legislation. This specific grant provides funding to city, county, and city and county agencies in California for waste tire enforcement activities. Tire Amnesty Grant Program

This program is a competitive grant program designed to help divert waste tires from landfill disposal and prevent illegal tire dumping. Funds are used to hold collection events in convenient locations for the public to bring their tires, in noncommercial quantities, at no charge. California cities, counties, special districts, Qualifying Indian Tribes, and other political subdivisions and jurisdictions joined together by formal agreements are eligible to apply.

CalRecycle has allocated \$1,800,000 for the Local Government Waste Tire Amnesty Grant Program for fiscal year (FY) 2015-16. Applications are due March 5, 2015. For additional information visit:

> AB 190 (Paper Bag Ban) and AB 191 (Paper Bag \$.10 fee) – Mayor Mary Ann Lutz made a motion to send a letter to oppose AB 190 and AB 191, seconded by Ms. Betsey Landis. The motion carried with six abstentions (Mr. Gerry Villalobos, Mr. Ed Pupka, Mr. Chris Salomon, Ms. Margaret Clark, and Mr. Mike Mohajer).

> AB 199 (Alternative Energy: Recycled Feedstock) – Mayor Mary Ann Lutz made a motion to send a letter to support AB 199 if amended, second by Mr. Salomon. The motion carried unanimously.

AB 237 (Parcel Taxes: Notice) – Staff recommends a watch position on this bill.

AB 239 (AB 32 Regulations) – Mr. Mohajer made a motion to send a letter to support AB 239, seconded by Ms. Clark. The motion carried with three abstentions (Mr. Salomon, Mr. Villalobos, and Mr. Ed Pupka).

SB 32 (AB 32: Emission Limit) – Mr. Mohajer made a motion to oppose SB 32, seconded by Ms. Landis. The motion carried with three abstentions (Mr. Salomon, Mr. Villalobos, and Mr. Ed Pupka).

SB 47 (Synthetic Turf) – Ms. Landis made a motion to send a letter to oppose SB 47 with an explanation on the body that the Task Force opposes pending further studies, seconded by Mr. Salomon. The motion carried with two abstentions (Mr. Salomon and Mr. Villalobos).

SB 350 (Renewable Energy) – Staff recommends a watch position since the language is not in print.

Mayor Mary Ann Lutz updated the Task Force on the Organics Workshop. The committee will be having a meeting in two weeks and will be discussing the time frame of the conference, sponsors, and location of the workshop.

IX. PUBLIC COMMENT
