#### I. CALL TO ORDER

Mr. Fahim Rahimi called the meeting to order at 10:02 a.m.

#### II. APPROVAL OF MARCH 16, 2023, SUBCOMMITTEE MINUTES

Mr. Mike Mohajer made a motion to approve the March 16, 2023 minutes and Mr. Wayde Hunter seconded. Minutes approved unanimously.

#### III. UPDATE ON CONVERSION TECHNOLOGY PROJECT DEVELOPMENT

Ms. Christine Arbogast reported that Tetra Tech continues to support Public Works with the following:

- Tetra Tech continues to identify potential sites for organic waste processing or thermal conversion facility development and is evaluating several old landfills within Los Angeles County.
- Tetra Tech is assisting with the preparation of a grant application for CalRecycle's Organics Grant Program, Cycle 7 for development of a proposed anaerobic digestion (AD) facility at the Calabasas Landfill.

#### IV. UPDATE ON CONVERSION TECHNOLOGY POLICY AND LEGISLATION

Mr. Rahimi provided the following update:

- At CalRecycle's monthly meeting on March 21, 2023, CalRecycle provided an update that they are now accepting applications for Senate Bill (SB) 54 (2022) Advisory Board members and the application deadline is April 24, 2023. The Advisory Board will provide feedback to assist with successful implementation of SB 54. The Advisory Board will be appointed in June 2023 and begin their services in July 2023.
- CalRecycle held an SB 54 informal workshop on March 29, 2023. The informal workshop included an informational session on the Producer Responsibility Organization. The workshop also provided opportunities for stakeholder feedback on rulemaking concepts.
- At the most recent CalRecycle monthly meeting held on April 18, 2023, CalRecycle mentioned that they will be holding another SB 54 informational workshop on April 25, 2023, which will focus on the covered materials. The informational workshop will also provide an opportunity for stakeholders to provide feedback on rulemaking concepts. CalRecycle mentioned that applications for the \$154 million in Organics Grant Funding are due by May 2, 2023.
- CalRecycle held an SB 1383 Chat on April 19, 2023, which focused on Local Education Agencies.

#### VI. PRESENTATION BY ECONWARD

Mr. Joe Ayala, of Econward provided a <u>presentation</u> on their technology which combines hydrolysis and AD to transform organic waste into biogas and digestate. He also played a <u>short video</u> introducing the company and its technology.

Mr. Mohajer asked Econward how they were able to determine that the 260,000 tons of feedstock they would receive per year is split evenly between organic and non-organic waste, which contradicts California waste characterization studies. Mr. Ayala stated that the feedstock composition is an estimate that was used to calculate potential biogas and digestate production. He clarified that the technology is capable of processing waste streams with various compositions of organic and non-organic waste.

Ms. Arbogast from Tetra Tech asked how many Econward facilities are currently operating. Mr. Ayala stated that they currently have one commercial facility located in Madrid, Spain.

Ms. Michelle Dewey requested the link to Econward's video. Mr. Rahimi replied that the link will be provided to the Subcommittee members. Ms. Dewey asked about Econward's involvement in any pilot projects at Yolo County Central Landfill. Mr. Ayala stated that they worked on a California Environmental Quality Act (CEQA) permit for a project at the landfill three years ago. He stated that the permit was granted but Econward chose not to proceed with the project.
