# I. CALL TO ORDER

The meeting was called to order at 11:02 a.m.

#### II. APPROVAL OF MINUTES FOR MEETING OF JULY 16, 2008

A motion to approve the Minutes of the July 16, 2008, meeting was unanimously approved.

# III. DISCUSSION OF FINDING OF CONFORMANCE FOR SUNSHINE CANYON LANDFILL (CITY/COUNTY LANDFILL)

Mr. Martin Aiyetiwa presented the Staff Report (See Attachment) on the Amended Finding of Conformance (FOC) application, dated August 6, 2008, submitted by Browning-Ferris Industries of California, Inc. (BFI) for the combined operation of the "Sunshine Canyon Landfill (SCL) – City/County Project."

The Subcommittee examined whether the Amended FOC (1) addressed the issues raised by the Subcommittee at the July 16, 2008, meeting, (2) provided the information requested by the Subcommittee at the July 16, 2008 meeting, and (3) fully addressed and complied with CSE Chapter 10 (Finding of Conformance) and Table 10-1 (FOC Submittal Requirements).

After a lengthy discussion between the Subcommittee, BFI representatives consultants. and County Counsels (Mr. Larrv Hafetz and and Michael L. Moore), the Subcommittee concluded that the submittals did not satisfy the following FOC requirements: (1) Requirement No. 5 of Table 10-1, regarding description of waste material to be handled, including a clarification on whether liquid waste is allowed, (2) Requirement No. 15 of Table 10-1, regarding information and operations plan for meeting applicable permit/regulatory requirement, since the evidence of the City of Los Angeles' approval determination for operation in Phase II has not been provided, and (3) Requirement No. 16 of Table 10-1, regarding demonstration of compliance with siting criteria requirements as established in Chapter 6 of the CSE, including a more thorough description of all the waste diversion and salvage programs that BFI is currently implementing.

It was resolved that since the Task Force does not issue a conditional FOC, an FOC will not be issued at this time. A motion was made stipulating that, (1) Subcommittee will proceed with the review of the proposal, (2) staff will continue to work with BFI to verify and obtain the remaining information, (3) staff will then prepare an updated Staff Report to the Subcommittee for review and consideration, and (4) once the above steps have been met, the FOC would be essentially finalized, but (5) the Task Force would withhold granting the FOC until after BFI provides evidence that BFI has obtained the City of Los Angeles' approval/determination to proceed to Phase II of the City Landfill.

A motion was passed stipulating the above, with Mr. Chris Salomon dissenting.

## IV. OPEN DISCUSSION/PUBLIC COMMENT

Mr. Wayde Hunter of the North Valley Coalition/Granada Hills North Neighborhood Council commented that BFI's FOC Application for the Combined Sunshine Canyon Landfill is premature, and there should be no further consideration on the FOC Application until all prerequisite regulatory requirements have been met.
