Hello, EMT! Hope everyone had a great summer and is getting ready for the holidays. The year-end is approaching quickly and so is the time to schedule hangar inspections. Please be sure to make some time available (10 minutes) to get yours done.

## Airport Ops & Admin

We are noticing a high volume of commercial vehicles (semitrucks) entering the airport and driving on the ramp. Please contact airport management to coordinate deliveries as these vehicles can cause serious damage to our ramp due to their heavy (80,000 lbs.) weight when fully loaded. We have a designated staging area to receive deliveries from commercial vehicles.

Try to help us help you by being inspection-ready during your hangar inspection. The following items will need to be provided or verified during your inspection. Having these ready ahead of time makes your inspection go a lot faster and hassle-free.

- FAA Aircraft Registration
- Airworthiness Certificate
- Last Annual Inspection
- If you have an Experimental Aircraft, please provide current special flight permit, or experimental certificate, or provisional airworthiness certificate as applicable.

Non-aviation self-storage tenants will be required to provide the following policies: general liability, automobile liability, and personal property insurance. If you have questions, please give us a call for details at (626) 448-6129.

## County Airports Serve As Cooling Centers During the Hot Summer Months

This year has been and continues to be a hot one! In fact, temperatures in Los Angeles reached 114 degrees this summer, which some climate officials have said has been the hottest on record.

The County's Office of Emergency Management coordinates with various partners/public facilities throughout the County to provide Cooling Centers (indoor air-conditioned locations) where people can keep cool during periods of extreme heat weather conditions.

During periods of excessive heat warnings (when temperatures meet or exceed 105 degrees for at least two days), the terminal buildings at the County's airports, particularly General Wm. J. Fox Airfield in Lancaster, Whiteman Airport in Pacoima, and San Gabriel Valley Airport in El Monte, have been made available this summer as Cooling Centers.

Hopefully, we'll now see a cooling trend as we leave summer and enter fall. However, the County's airports will continue to serve as Cooling Centers when needed, which is one more way the airports can serve not only general aviation but the diverse constituents of, and visitors to, the County of Los Angeles.
