# **Airport Improvement Projects**

#### **Airport Sewer Pump and Force Main Project**

The airport's sewer pump station and force main were built in the 1950s and have exceeded their useful lives. Installation of a completely new system has been underway and is expected to be completed by early August.

#### North Runway and Taxiways Pavement Project

Design is underway and should be completed later this year for the rehabilitation of the north runway (8L26R) and associated taxiways pavements. Construction is anticipated to begin in 2027 and will require closure of the runway and portions of the taxiways.

#### **New Airport Traffic Control Tower**

Funded through the Bipartisan Infrastructure Law, the FAA will be building and operating a new and modern Airport Traffic Control Tower facility at a new location on the airport, just east of the current tower. At this time, there isn't an anticipated schedule for construction.

# Repair Updates

# Terminal Building Heating, Ventilation, and Air Conditioning (HVAC) System

The Heating, Ventilation, and Air Conditioning (HVAC) system serving the airport terminal building is currently out of service. A temporary cooling unit is now in place to serve the terminal building while repairs are under way.

#### **North Vehicle Access Gate**

Repairs to the north vehicle access gate were recently completed and the gate is now fully operational.
