P R E F A C E
1980 Adjustment

The Road Department level net published in 1975 consisted of more than 1500 miles of levels supporting in excess of 18,000 bench marks. For reasons of economy, this 1980 adjustment is reduced to about 55% of the bench marks previously published. Reductions were made by increasing the spacing between level lines in unincorporated territory, and eliminating lines in non-contract cities and areas where the probability of future engineering projects appears slight. The 1980 adjustment is an update of the remainder of the 1975 bench marks, not including baselines. Data from previous adjustments is available without inferring any responsibility for the current reliability of the data or the actual existence of the bench marks. Elevations of bench marks with the same quad name, but different adjustment dates, are not normally compatible.

To facilitate the adjustment, indexing, and distribution of adjusted values of the net, the County territory is divided into 34 quads or areas. For identification purposes each quad is given a name, viz., "Rosemead," "La Mirada," "Santa Fe," etc. When bench marks and elevations in the Road Department net are used, the name of the quad in which the bench mark is located and the date of the elevation adjustment must be included in the bench mark description, e.g.,

The precision of the net is reflected by an indicated field probable error of plus or minus 0.012 foot per mile of leveling as determined from over 300 conditions of closure. However, many years experience in vertical control in the greater Los Angeles basin and Antelope Valley indicate that because of varying degrees of subsidence and heaving, the true datum is recovered only by obtaining substantial agreement between a number of bench marks.






