The proposed project would also include walkway improvements to provide access to the beach and the renovated building from the promenade; reconstruction of the asphalt pavement and replacement of the boat storage racks at the outdoor boat storage area that are in poor condition; and landscaping improvements with drought tolerant plantings, water efficient irrigation, and planters with bioretention devices to capture, filter, and infiltrate stormwater runoff from the site.
