Description of Nature, Purpose and Beneficiaries of Project:

On February 4, 2025, the County of Los Angeles Board of Supervisors approved the Barry J. Nidorf Secure Youth Track Facility Security and Kitchen Upgrades Project. Barry J. Nidorf is a juvenile detention facility operated by the County. The delivery method of this project will provide additional security measures for the facility.

This project included the installation of a netting system above the west, north, and east perimeter walls. It will add an additional 12 feet to the height of the perimeter walls to deter contraband from being thrown over the facility wall. The project also includes two new fan coil units and a rooftop condensing unit to cool the dry food storage room adjacent to the facility's kitchen.
