## Illegal Dumping Quarterly Summary – Adriana Ornelas

Adriana Ornelas from Public Works provided the summary of the current Illegal Dumping Incident Report for the Antelope Valley areas. Annamarie Dyemartin, from the Littlerock Town Council, inquired why Unincorporated areas of Los Angeles County total monthly illegal dumping incident reports (51) were significantly less than the City of Lancaster (320) and the City of Palmdale (107). Ms. Dyemartin suggested that residents may not be aware of the County's Illegal Dumping Hotline number.

Adriana Ornelas explained that the total incident reports are compiled from data entered in the Illegal Dumping Tracking System. The public also report illegal dumping incidents directly to Public Works Road Maintenance Field Yards. Adriana Ornelas will verify this information with Public Works Road Maintenance.

Ariel Verayo from the Agricultural Commissioner/Weights and Measures, Weed Abatement Division requested a count for the number of illegally dumped vehicles removed from private property. Karen Tandler from the District Attorney's office shared that the Sheriff's Department would have to report these vehicles before or after they are towed.

# **Mattress Recycling Collection Summary – Adriana Ornelas**

Adriana Ornelas motioned to continue the incentive program for the Spring 2018 mattress collection events where residents receive a \$5 target gift card for each mattress or box spring they drop-off up to a maximum of \$30. Karen Tandler seconded the motion. Hossein Torabzadeh from Public Works stated the Subcommittee did not have quorum to pass the motion. Motioned was tabled for the June 2018 Task Force meeting. Annamarie Dyemartin asked if the incentive program had any impact on the number of mattresses dropped off. The data wasn't available at the time but Adriana Ornelas would research and answer Annamarie's question.

# Discussion on AVIDTF Subcommittee responsibilities, procedures, and bylaws development and adoption – Karen Tandler

Karen Tandler from the District Attorney's Office reported that Tiffany Caldwell from the Department of Regional Planning was working on creating the Task Force bylaws.

# Request for "No Dumping" signs between Palmdale Boulevard and East Avenue T – Hossein Torabzadeh

Hossein Torabzadeh responded to Ms. Annamarie Dyemartin's request for "No Dumping" signs on East 170th street between Palmdale Boulevard and East Avenue T. Public Works' Road Maintenance Division investigated the need for "No Dumping" signs

on East 170th Street. The investigation revealed that "No Dumping" signs on East 170th Street are not warranted; therefore, the request was denied.

### Weekend Trash Collection Service with Waste Management (WM)- Josh Mann

Annamarie Dyemartin asked why WM roll-off bins cannot be used for weekend community cleanup events. Josh Mann from WM of Lancaster explained that the company truck drivers have a union agreement that has restrictions on weekend work. In addition, the Lancaster Landfill closes at 12 noon on Saturdays and is closed on Sundays. Therefore, bins cannot be collected over the weekend. However, roll-off bins can we provided if they are stored in a secure area over the weekend. The roll-off bins will be collected during the week immediately following the event. Another option would be to schedule the community events to end before 12 noon on Saturdays in order for WM truck drivers to pick-up the bins.
